**16HDC-45** (148 WALKER ROAD) – proposal to replace front door and storm door with doors of different design. Applicant: CASTLE WINDOWS. Owner: MARK & CLAUDIA DROSTE. Parcel ID: 15-38. <continued from 9.12 hearing>

The Applicant withdrew the application prior to 9.15 hearing.

**16HDC-38** (19 BANKS TERRACE) – proposal to replace the existing replacement window on side of house with like material/design. Applicant: MICHAEL NAPLES. Owner: CATHERINE & JOHN PHELAN. Parcel ID: 16-97. <continued from 9.12 hearing>

R Smith introduced the topic of dedicated benches being installed in and around the Lilac garden on Monument Ave. It was agreed that this should be discussed further at a future meeting.

S Belkin mentioned that the Commodore at the Fish House intends to rebuild the deck, and that it will likely be townfunded. Gino Cresta is creating the Scope of Work. S Belkin also noted that the window sashes have been remove, allowing for weather to enter the building.
