Jay Duffy reported how the story came to his attention. N. Schultz discussed the additional research she had done on the tenants of the house. This seems to be the only house on the North Shore that was listed in the Green Book. The Commission could pursue a form B for the house and neighborhood. K. Barry will look into the National Registry on the basis of location. J. Oliver will pursue the MACRIS. We discussed numerous ways to highlight this history, including doing an exhibition in 86 Burrill, posting a story on the commission's Facebook page, and possibly writing an article for the Reporter or 01907. J. Oliver moved to develop a Form B, K. Barry seconded. Unanimously approved. R. Smith and D. Anderson will fill out the architectural details for the house.
