Kevin - Champ has approximately 20,000 families on the waitlist. Public Housing has approximately 14,000+.

SHA is experiencing a lot of unit turnover. There are currently 5 empty units and 2 units ready to be rented. 2 more units will become available by the end of the month.

Cynthia requested a written commendation on record for how quickly Kevin has turned around units.

Annual inspections starting tomorrow at Doherty. Inspections haven't been conducted in approximately 4 years. Kevin's goal is to have every unit inspected by the end of the fiscal year.

The state gives 14 days to fix any identified problems an inspection reveals.

Reserves are holding at 41%.

<u>Old Business</u>- Sean Regan-Bylaws and Personnel Policy are not in as bad a shape as previously thought. Sean plans to have a redline version draft for the board to review before next board meeting. The draft will be reviewed at the next board meeting, to vote on at the following month's meeting.

Catherine will contact the other attorney regarding policies and procedures.

Board member training is now due by April 15<sup>th</sup>.

Need to keep PHN's in a binder. The Executive Director is supposed to bring a copy of the PHN to the board meeting.

New Business-Tom Driscoll

Swampscott Contributory Retirement System hasn't received a check from SHA since January. Tom is asking the board to be aware of the issues and help to figure things out.

Kevin requested approval to use wage match, which would help to reduce income fraud by tenants. Charlie made a motion to approve Kevin's use of wage match. Sean seconded.
