# CIVIL SERVICE STUDY COMMITTEE APPOINTMENT

Select Board Chair Peter Spellios reviewed the Town Meeting amendment that charged the Select Board with appointing one member to the new Civil Service Study Committee.

This Article was passed at Town meeting on 6/22 and 10 candidates responded. Town Moderator Michael McClung appointed three members: Ralph Edwards, Heather Roman, and Thelma Young. The Police and Fire Union appointed a 4<sup>th</sup> member, Candace Delano.

There was a conversation regarding the process of appointing the member and concern that the procedure was not clearly outlined and that some members were not aware that the Town Administrator would be making a recommendation to the board. Furthermore, some Select Board members were concerned that there was not enough time given for the members to review the list of candidates who applied to be considered.

Director of Human Resources and Interim Town Administrator Julie Delillo spoke briefly to recommend David Vera to the Commission.
